The Federal Regulations were updated by one amendment that affected 36 sections of the Guide. Six GPTC transactions affected 16 sections of the Guide. Editorial updates include application of the Editorial Guidelines, updating reference titles, adjustments to page numbering, and adjustment of text on pages.
