Foreword (This Foreword is not part of American National Standard Z15.1-2017)

This standard is a revision of the existing standard, which was originally published in 2006. It is one of an expected series of safety standards addressing motor vehicle operations. It is expected that these standards serve as a guide to organizations with vehicle operations.

This standard is not intended to serve as a guide to governmental authorities having jurisdiction over subjects within the scope of the Z15 Accredited Standards Committee (ASC).

Revisions: The Z15 Committee welcomes proposals for revisions to this standard. Revisions are made to the standard periodically (usually five years from the date of the standard) to incorporate changes that appear necessary or desirable, as demonstrated by experience gained from the application of the standard. Proposals should be as specific as possible, citing the relevant paragraph number(s), the proposed wording, and the reason for the proposal. Pertinent documentation would enable the Z15 Committee to process the changes in a more-timely manner.

Interpretations: Upon a request in writing to the Secretariat, the Z15 Committee will render an interpretation of any requirement of the standard. The request for interpretation should be clear, citing the relevant paragraph number(s) and phrased as a request for a clarification of a specific requirement. Oral interpretations are not provided.

Only the Z15 Committee (through the Z15 Secretariat) is authorized to provide any interpretation of this standard.

Approval: Neither the Z15 Committee nor American National Standards Institute (ANSI) approves, certifies, rates or endorses any item, construction, proprietary device or activity.

Appendices: Appendices are included in most standards to provide the user with additional information related to the subject of the standard. Appendices are not part of the approved standard.

Committee Meetings: The Z15 Committee meets on a regular basis. Persons wishing to attend a meeting should contact the Secretariat for information.

Standard Approval: This standard was processed and approved for submittal to ANSI by the American National Standards Committee on Motor Vehicle Fleet Operations. Approval of the standard does not necessarily imply (nor is it required) that all committee members voted for its approval.
