
## AWWA Management Standard

This document is an American Water Works Association (AWWA) management standard. It is not a specification. AWWA management standards describe consensus requirements for utility management practices. The use of AWWA management standards is entirely voluntary. This standard does not supersede or take precedence over or displace any applicable law, regulation, or codes of any governmental authority. AWWA management standards are intended to represent a consensus of the water industry of requirements and practices that utilities should strive to achieve. When AWWA revises or withdraws this standard, an official notice of action will be placed in the Official Notice section of *Journal AWWA*. The action becomes effective on the first day of the month following the month of *Journal AWWA* publication of the official notice.
