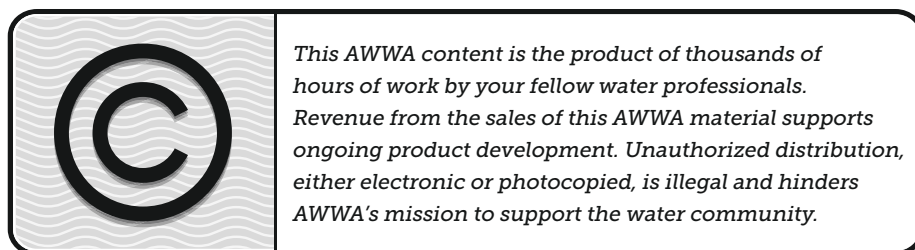
## AWWA Standard
