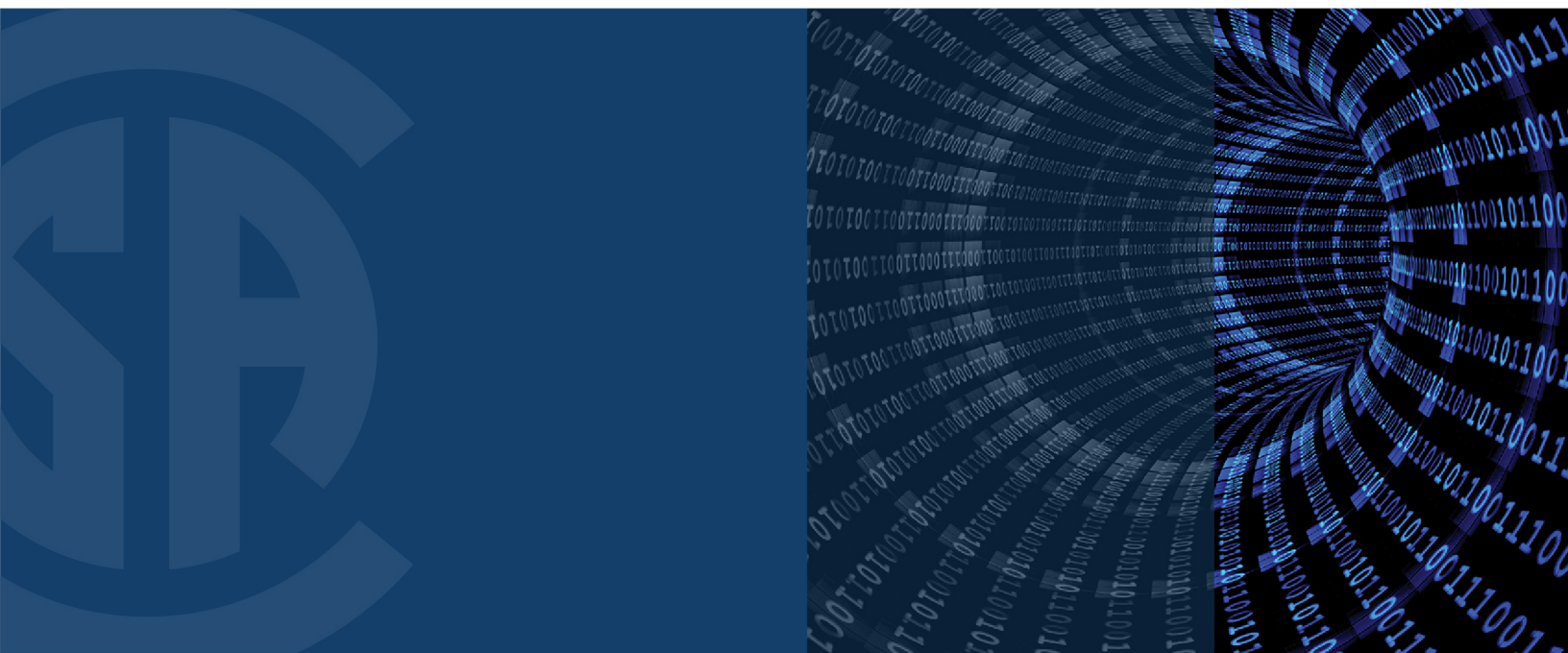

## Foreword
