## Amendments

This standard differs from DIN EN ISO 11290-2:2005-01 as follows:

- a) the enumeration of *Listeria monocytogenes* has been modified as listed below;
- b) primary suspension with buffered peptone water, half-Fraser broth with or without supplements, and all appropriate diluents referred to in ISO 6887 (all parts) has been included;
- c) the resuscitation step has been deleted;
- d) the microscopic aspect, catalase and CAMP test for confirmation have been made optional;
- e) new performance characteristics have been included;
- f) moreover, the enumeration of *Listeria monocytogenes* has been included in the scope and the title has been changed accordingly.
