## National foreword

This standard includes safety requirements within the meaning of the *Produktsicherheitsgesetz (ProdSG)* (German Product Safety Act).

This document (EN 1176-3:2017) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational facilities and equipment" (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was *DIN-Normenausschuss Sport- und Freizeitgerät* (DIN Standards Committee Sports Equipment), Working Committee NA 112-07-01 AA "Playground equipment".

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that slides which comply with this standard fulfil the relevant health and safety requirements.

## Amendments

This standard differs from DIN EN 1176-3:2008-08 and DIN EN 1176-3 Corrigendum 1:2008-12 as follows:

- a) the definition for wave slide has been deleted;
- b) the figure for the illustration of the position of the sections of a slide has been revised (see Figure 2);
- c) the free height of fall if the starting section is easily accessible and no guarding is provided has been reduced;
- d) the maximum length of the initial straight sliding section and of the second sliding section after a bend has been specified (subclause 4.4.1 and Annex B);
- e) Table 1 has been revised;
- f) the impact area for Type 1 if the sliding section is maximum 1 500 m has been reduced;
- g) Figure 5 has been revised;
- h) the start of the free space on a slide has been specified;
- i) an A-deviation for Romania has been included;
- j) parts of the standard series EN 1176 have been linguistically harmonized with each other;
- k) the standard has been editorially brought in line with the current rules of presentation.
