This document (EN ISO 16090-1:2013) has been prepared by Technical Committee ISO/TC 39 "Machine tools", Subcommittee SC 10 "Safety" in collaboration with Technical Committee CEN/TC 143 "Machine tools — Safety" (Secretariat: SNV, Switzerland).

The responsible German body involved in its preparation was *DIN-Normenausschuss Werkzeugmaschinen* (DIN Standards Committee Machine Tools), Working Committee NA 122-10-04 AA "Machining Centres — Safety" which played a major role in the development of this document and also oversaw the German translation.

The International Standards produced by ISO/TC 39/SC 10 in collaboration with CEN/TC 143 apply in particular to machine tools and complement the relevant A and B standards on the subject of general safety (see Introduction to ISO 12100:2010 for a description of type A, type B and type C standards).

This standard describes the current state of technology as regards safety and occupational health in the presence of machining centres, milling machines and transfer machines. It is a type C standard for machines meeting the essential safety and health requirements laid down in Annex I of the revised Machinery Directive (Directive 2006/42/EC).

- a) the previous editions of DIN EN 12417, DIN EN 13128 and DIN EN 14070 have been combined in this document and the machines have been divided into Groups 1 to 4;
- b) instead of the categories used for the definition of safety functions in DIN EN 12417, DIN EN 13128 and DIN EN 14070, the required performance level according to DIN EN ISO 13849-1 has been defined for relevant safety functions;
- c) the list of safety functions has been extended and brought in line with the state of the art;
- d) the technical safety requirements for the machines have been brought in line with the state of the art;
- e) the mode of safe operation service has been defined and described;
- f) the requirements for the noise test have been revised;
- g) normative references have been updated.
